#### **AUTHORIZING AND ADOPTING THE SANDOVAL COUNTY DWI AND PREVENTION PROGRAMS MISDEMEANOR COMPLIANCE FEES FOR FISCAL YEAR 2015-2016 AND REPEALING RESOLUTION NO. 6-19-14.7**

**WHEREAS**, State of New Mexico, Department of Finance and Administration has allowed the DWI Programs to charge programs fees; and

**WHEREAS**, the program fees offset costs that occur during supervised probation when the individual is referred by Courts in Sandoval County; and

**WHEREAS**, on June 19, 2014 the Sandoval County Board of Commissioners approved Resolution No. 6-19-14.7; and

**WHEREAS**, the program fees, with the service to be provided, are listed below:

<b>Service Type - Description</b>	<b>Fee</b>
<b><u>Registration Fee</u></b> – Per charge/referral for court ordered clients being screened.  Per charge for self-referrals or those not convicted in Sandoval County, who are utilizing DWI and Prevention services (Treatment, UA's, etc.)	\$10.00  \$20.00
<b><u>Screening Fee</u></b> – Per charge/referral for court ordered clients being screened as per statute.	\$30.00
<b><u>Probation Fee</u></b> – Per month.	\$30.00
<b><u>Alcohol Monitoring Fee</u></b> – Per day depending on the type of monitoring device.	\$4.00 - \$9.00

<b>Drug Testing Fee</b> – For individuals referred that are not on supervised probation and have been Court ordered; cost per test for confirmed results. Registration fee required to provide this service.	\$30.00
<b>Out of State Drug Testing Fee</b> – Individuals who require testing and or confirmed results to be submitted to another program; cost per test. Registration fee required to provide this service	\$50.00

**NOW THEREFORE BE IT RESOLVED** that the Board of County Commissioners hereby approve the **"DWI Misdemeanor Compliance Fees"** for FY 2015-2016.
