- Proposed ordinance an attempt to take mineral rights from property owners.
- Public meetings are of only token value
- NM Tech's participation is about politics and money.
- Do agree with protecting water quality.
- Protect environmental health and safety (Oil and Gas Accountability Project/OGAP).
- Public meetings on ordinance are of value. (OGAP)
- Proposed ordinance does not deal with environmental impacts, is inadequate for addressing environmental and cultural resource impacts. (OGAP)
- Financial, legal consequences for County. (OGAP)
- Oil accident in Carlsbad: what were costs to the State? (OGAP)
- Need more time, more time to review proposed ordinance. Revise current draft based on citizen's comments. (OGAP)
- Guidance on proposed ordinance from oil industry also important. (OGAP)

- State does not pre-empt County on permitting, land use issues. (OGAP)
- Gaps in Federal, State regulations can be addressed by counties. (OGAP)
- State Pit-Rule changes result in less State regulation. (OGAP)
- Rio Arriba County's oil and gas ordinance has county regulations more stringent that State regulations. (OGAP)
- NM Tech can assist in establishing stringent drilling standards. (OGAP)
- State penalties to oil and gas industry date back to 1930's, need updating. (OGAP)
- Should County have its own oil and gas operator permits? (OGAP)
- OCD should consider out-of-state track record for oil and gas companies applying for permits in NM. (OGAP)
- State records had to locate in OCD data information. (OGAP)
- Industry impacts vary widely, contamination does not respect property boundaries. (OGAP)
- NM is too financially dependent on oil and gas industry. (OGAP)
- Additional experts needed at State level. (OGAP)
- Proposed ordinance interferes with property rights, will be litigation.
- 37% of northern county residents live at poverty level. Rural living very different from southern County living.
- Environmental actions suppress money, jobs.
- North County area wants out of Sandoval County, should be in another county.
- Exploratory oil and gas activity should be more separate in regulations, view production as to be determined.
- Geology of Rio Rancho Estates area still active.
- Water bearing zones well defined in area, should be mapped.
- Fracking during exploratory drilling vertical only, not horizontal.
- Look at geology and water supply. More fracking requires more water.
- Drilling in geologic fault areas may result in contamination.
- More geologic studies needed.
- So many negative comments about proposed oil and gas ordinance, yet ordinance is still going forward.
- Who benefits from the revenue of oil and gas?
- Where does oil go that is collected in New Mexico, where is it shipped?
- Concerns over flaring of methane.
- Why drill in New Mexico? Why drill in Sandoval County?
- Do the ordinance "right".
- Protect property and mineral rights.
- Economic development vs. potential harm industry creates.
- Look to Eddy County as an example of economic benefit from oil and gas industry.
- Support oil industry (NM Business Coalition/NMBC).
- Oil industry a major employer in NM. (NMBC)
- Operators do care about water, air, wildlife. Industry is responsible. (NMBC)

- Industry provides 30% of State revenue, best paying jobs, majority of funding for schools. (NMBC)
- Work with the oil and gas industry. (NMBC)
- Take more time to develop oil and gas regulations. Proposed oil and gas ordinance setting a precedent in NM. (NMBC)
- In Oklahoma, 37 waste wells closed due to well-related seismic activity.
- Industry not concerned with community welfare, only profits.
- County must represent health and safety.
- San Miguel, Santa Fe counties have health and safety oriented oil and gas ordinances.
- Other industries such as eco-tourism and alternative energy development can be profitable in NM.
- NM is a scenic nature state, protect NM natural resource.
- 500 oil and gas wells currently in operation in Sandoval County.
- Oil and gas regulations should balance industry with needs of community.
- In San Juan County, County and State agencies work together on oil and gas.
- Safety is important.
- Protecting the environment is a good thing. Oil and gas industry not credited enough with the good things it does with environment.
- Don't rush oil and gas ordinance development. Standards are important.
- Input from northern County communities is needed in this process, many people there rely on oil and gas industry for their livelihood.
- Health, safety, welfare provides for many needs across all other industries. (NMOGA)
- There is no modern economy without industry. (NMOGA)
- Energy still largely imported. (NMOGA)
- U.S. standards on energy development are the most strict internationally. (MNOGA)
- Definitions: check State, Federal laws, avoid overlaps and confusion. (NMOGA)
- Delineation: overlap leads to uncertainty, costs to industry and regulators. (NMOGA)
- Details are important in regulation development. (NMOGA)
- Duration: industry does well to implement regulations. Industry needs more time for input on regulation development. (NMOGA)
- Oil and gas employees live and work here in NM. (NMOGA)
- Oil and gas industry seeks to do voluntary water quality testing with private land owners. (NMOGA)
- Do not interfere with property owner subsurface rights. Keep regulations fair.
- What are the social costs of an industry that is not regulated for health and safety? Is this a social crime? (Food and Water Watch/FWW)
- NM Tech does not address social crime issues. (FWW)
- What is the impact of oil and gas industry on property values? (FWW)
- All people are important. (FWW)
- County should pursue development of renewable clean energy. (FWW)
- County should adopt a public participation policy on all planning projects. (FWW).
