The County shall review and revise as needed. The County may require the applicant to secure Right Of Way (ROW) Permits for County roads. The applicant may also be required to secure Right-of-Way (ROW) Permits for municipal and/or State roads where needed. The County may require the applicant to provide a cash bond security, a letter of credit, escrow deposit or other method acceptable to the County, and/or Road Improvement Agreement for use of County roads. Public Works shall review and approve the road plan and determine type of assurance needed to maintain and make necessary repairs to County roads used per the road plan. The Public Works Director or their designee shall approve the Road Plan within 30 days.

Emergency Response Plan. Plan identifying all fire, police, and emergency response services in the County that are within five miles of the drill site as well as a description of standard operating procedures, including applicable health, safety and environment protocols, used by the operator in the event of emergencies. The Emergency Response Plan must include a section for fire protection and when the permittee will call emergency responders. The <u>Fire Chief or their designee</u> shall review and approve the Emergency Plan and this approval should take no more than 30 days and be completed concurrent with the Road Plan,

This language gives us the ability to work with the oil and gas industry to maximize life safety and asset protection. We will create a streamlined process to include forms for reviewing new oil well applications. A timeline of 30-days for the review will allow us to move the process along efficiently. The Emergency Response Plan needs to include a section for fire protection and when the permittee will call emergency responders.
