# 2018 Primary Election Proclamation

Pursuant to Article 8 Section 1-8-15 Election Law of the State of New Mexico, I, Eileen Garbagni, County Clerk of the County of Sandoval, by virtue of the authority vested in me, do hereby issue the following **PROCLAMATION**:

That a Primary Election be, and the same is hereby called to be held throughout the County of Sandoval and in each Precinct thereof, on the  $5^{th}$  day of June 2018; and

That the Primary Election shall be applicable to the following political parties, to wit: the Democratic Party, the Republican Party and the Libertarian Party; and
