SANDOVAL COUNTY BOARD OF COMMISSIONERS REGULAR MEETING MINUTES COMMISSION CHAMBERS FEBRUARY 15, 2018 6:00 P.M.

1. CALL TO ORDER

Chairman Heil called meeting to order at 6:05 p.m. Present were Chairman Heil, Vice Chairman Eichwald, Commissioner Block, Commissioner Holden-Rhodes and Commissioner Chapman.

2. PLEDGE OF ALLEGIANCE

Pledge of allegiance was led by Chairman Heil.

3. INTRODUCTIONS & ANNOUNCEMENTS

Chairman Heil advised a change in the agenda Item 8 will be moved immediately following Item 4A. Commissioner Block requested a moment of silence in view of the recent tragedy in Florida and the two police officers killed in the line of duty in Ohio. (Paula Enyeart, Sandoval County Fair Board President)

Vice Chairman Eichwald suggested that we need more publishing of this event and get more volunteers from all areas of Sandoval County, not just the Cuba area and the surrounding towns.

Ida Fierro and Andrew Edmondson presented and requested funding for Highway 550. Clerk Garbagni called for vote. Motion passed, vote was unanimous. Judge George P. Eichwald swore Charles Christmann into office as the Probate Judge.

9. OFFICE OF THE COUNTY MANAGER

(Dianne Maes, county Manager)

Request for a Motion to Approve the Professional Services Agreement with Brent Yessin, Esq. To Represent the County in Right to Work Litigation. Commissioner Block motioned to approve, seconded by Chairman Heil, Commissioner Chapman advised that he had spoken with the County Attorney concerning the procurement code and her opinion and had several other concerns and recommended more clear language in the agreement. Commissioner Chapman advised for the record that he would vote no. Commissioner Chapman motioned to table, seconded by Vice Chairman Eichwald. Clerk Garbagni called for vote, Motion to Table passed. Commissioner Block and Commissioner Holden-Rhodes voted no. Vote was 3-2.

10. DETENTION CENTER

(Rob Burpo, FAFA)

Request for a Motion to Adopt a Resolution No.2-15-18.10 Directing the Publication of a Notice of Intent to Adopt two Ordinances each Imposing one 1/16th of one percent (0.625%) increment of the County Correctional Facility Gross Receipts Tax.

Rob Burpo presented. Vice Chairman Eichwald motioned to approve, seconded by Commissioner Holden-Rhodes, Clerk Garbagni called for vote, Commissioner Chapman voted no. Motion passed. Vote was 4 to 1.
