## SANDOVAL COUNTY BOARD OF COMMISSIONERS REGULAR MEETING MINUTES COMMISSION CHAMBERS MARCH 1, 2018 – 6 P.M.

#### 1. CALL TO ORDER

Chairman Heil called meeting to order at 6:03 p.m. Present were Chairman Heil, Vice Chairman Eichwald, Commissioner Holden-Rhodes, Commissioner Chapman and Commissioner Block arrived at 6:14 p.m.

### 2. PLEDGE OF ALLEGIANCE

Pledge of allegiance was led by Chairman Heil.

# 3. INTRODUCTIONS & ANNOUNCEMENTS

Vice Chairman Eichwald introduced Tri Chapter President George Werito, Mario Atencio and Sam Sage. Chairman Heil advised that the County Manager sent a letter to BLM concerning the west wide energy corridor and had a conference call with them. Dianne Maes, County Manager summarized the findings to the board. Dianne Maes further advised that there would be a stakeholder meeting tentatively in June, 2018. Commissioner Holden-Rhodes explained the details of the map that was displayed. County Manager Dianne Maes announced the new Detention Director Gilbert V. Armendariz and thanked Chris Urbanic for filling in as the interim detention director.

Vice Chairman Eichwald motioned to move Agenda Item 9 after Agenda Item 7, seconded by Commissioner Chapman. Clerk Garbagni called for vote. Motion passed as amended. Vote was unanimous.

Lynette Schurdevin presented a flyer, Mildred Walter and Marian Frear presented information on all public libraries within Sandoval County. (See Attached)

C. Request to Obtain Information and Direction on Addressing Pipeline Safety in Placitas. (James Maxon, Fire Chief)

James Maxon, Fire Chief presented and informed the Commission of his response to a letter from the Las Placitas Association that he was tasked to prepare a response from the County Manager and the 11 concerns included in the letter he received. Chief Maxon has prepared five letters to the agencies that Dave Patterson has asked questions for clarification. Commissioner Holden-Rhodes stated that letters need to go out to state and federal agencies. Commissioner Holden-Rhodes stated that the U.S. Department of Transportation has advised him that a pipeline engineer will be going out to the site. Commissioner Chapman advised that the challenge is in the approved budget that comes out of Washington.

#### 7. CONSENT AGENDA

(Dianne Maes, County Manager)

Approval of the Minutes from the Board of Finance Meeting and Regular County Commission Meeting held February 15, 2018.

Commissioner Block motioned to approve, seconded by Vice Chairman Eichwald. Clerk Garbagni called for vote. Motion passed. Vote was unanimous.

### 8. SANDOVAL COMMISSION

A. Request for a Motion to Approve the Professional Services Agreement with Brent Yessin, Esq. to Represent the County in Right to Work Litigation.

Chairman Heil advised the Commission that he had a signed agreement from Brent Yessin, and also updated the Commission with the status. Commissioner Chapman questioned the agreement and local representation. Vice Chairman Eichwald commented that the County could be liable up to 4 times the amount if the County were to lose a lawsuit. Commissioner Block motioned to approve, seconded by Commissioner Holden-Rhodes. Clerk Garbagni called for vote. Commissioner Chapman voted no. Motion passed. Vote was 4-1

B. Motion to Approve Publication of Title and General Summary of the Proposed Ethic Ordinance. Acting County Attorney Heather Smallwood updated on the publication of title and general summary of the proposed ethics ordinance and advised of several changes, omissions and typographical errors that should be corrected before publication. Ethnics Committee Member Frank Narvaez was there as a spokesperson. Commissioner Chapman motioned to postpone or table, seconded by Commissioner Block. Clerk Garbagni called for vote. Motion to table and present at the next Commission Meeting passed. Vote was unanimous. Chairman Heil motioned to recess at 8:53. Reconvened at 9:02 p.m.

C. Request for a motion to approve Discussion and Approval of a Citizens Working Group for Aquifer Source, Water Protection and Oil and Gas Ordinance.

Several constituents commented of their concerns. Commissioner Chapman stated that he was not included in naming representatives from his district, Commissioner Eichwald stated that all tribal collaboration must be included. Commissioner Block recommended that the ordinance go through the Planning and Zoning process as well. Commissioner Holden-Rhodes motioned to strike Albuquerque Basin from the title of the group, seconded by Commissioner Block. Clerk Garbagni called for vote. Commissioner Chapman voted no. Vote was 4-1 Commissioner Chapman motioned to add additional names to the group, seconded by Vice Chairman Eichwald. Clerk Garbagni called for vote. Commissioner Holden-Rhodes voted no. Motion passed. Vote was 4-1. Commissioner Eichwald motioned to limit number of people in the group to 15, seconded by Commissioner Block. Clerk Garbagni called for vote. Commissioner Chapman and Commissioner Holden-Rhodes voted no. Motion to limit group to 15 passed. Vote was 3-2. Commissioner Block recommended that Mr. Phillips to write a charter for the Commission to review. Commissioner Block motioned to include the Planning and Zoning Commission's approval of the ordinance, seconded by Commissioner Chapman. Clerk Garbagni called for a vote. Commissioner Holden-Rhodes and Chairman Heil voted no. Motion passed. Vote was 3-2
