 Motion passed. Vote was unanimous.

 Commissioner Block motioned, seconded by Vice Chairman Eichwald. Clerk Garbagni called for vote. Motion passed. Vote was Unanimous.
- C. Request for a Motion to Approve Publication of Title and General Summary of the Proposed Ethics Ordinance. County Attorney Heather Smallwood advised and presented. Commissioner Block motioned, seconded by Commissioner Chapman. Clerk Garbagni called for vote. Commissioner Holden-Rhodes abstained, Vice Chairman Eichwald voted no. Motion to publish passed. Vote was 3 to 1.
- D. Request for a Motion to Approve a Memorandum of Understanding that Specifies the Obligation of both the City and the County with respect to the Meadows Blvd. Improvements / \$250,000 Vice Chairman Eichwald commented that all entities with-in Sandoval County should be considered with regard to road improvement funding requests. Chairman Heil commented about all road issues that the County is dealing with at this time. Commissioner Chapman commented that he is reluctant in supporting someone who would come out publicly and discount all that the commission is trying to do specifically the Town of Bernalillo, and utilities that were put in the 550 corridor were put in the wrong place in the first place. Chairman Heil also advised that the Santa Ana Pueblo, the Town of Bernalillo and Sandoval County, are all working in conjunction to resolve this matter. Commissioner Holden-Rhodes spoke of his concerns and stated he could not vote for this and questioned monies taken from District 1, Commissioner Chapman stated that he would appreciate Commissioner Holden-Rhodes refraining from mentioning this every time the Commission meets. Chairman Heil motioned, seconded by Commissioner Block. Clerk Garbagni called for vote. Commissioner Holden-Rhodes voted no. Motion passed. Vote was 4-1.
