## SANDOVAL COUNTY BOARD OF COMMISSIONERS REGULAR MEETING MINUTES COMMISSION CHAMBERS JULY 12, 2018 – 5:00 P.M.

## 1. CALL TO ORDER

Chairman Heil called meeting to order at 5:12 p.m. Present were Chairman Heil, Commissioner Block, Commissioner Holden-Rhodes and Commissioner Chapman. Absent was Vice Chairman Eichwald.

#### 2. PLEDGE OF ALLEGIANCE AND NEW MEXICO PLEDGE

## 3. APPROVAL OF AGENDA

Commissioner Block motioned, seconded by Commissioner Holden-Rhodes. Clerk Garbagni called for vote. Motion passed. Vote was unanimous.
