#### SANDOVAL COUNTY BOARD OF COMMISSIONERS REGULAR MEETING MINUTES JULY 26, 2018 – 6:00 P.M.

#### 1. CALL TO ORDER

Chairman Heil called meeting to order at 6:01 p.m. Present were Chairman Heil, Vice Chairman Eichwald, Commissioner Block, Commissioner Holden-Rhodes, and via telephone Commissioner Chapman.

#### 2. PLEDGE OF ALLEGIANCE AND NEW MEXICO PLEDGE

The Pledge of Allegiance and the New Mexico Pledge was led by Chairman Heil.

#### 3. INTRODUCTIONS & ANNOUNCEMENTS

Chairman Heil stated that prior to today's Regular Board of Commission Meeting, the Commission met in closed session as a committee of the whole to discuss the payment in lieu of taxes lawsuit, possible opiate litigation and limited personnel matter related to county attorneys' office, pursuant to open meetings act NMSA 1978, Section 10-15-(H) (7) and (2). Those matters discussed in the closed session were limited only to these issues and no action was taken. Commissioner Block recognized and welcomed Former County Commissioner Donnie Leonard, State Representative Daymon Ely, Former Rio Rancho City Councilor Cheryl Everett, Fire Chief James Maxon, and thanked the Sheriff, sheriff deputies and firefighters who responded to the worst highway accident involving a bus on I-25 north of Bernalillo. Chairman Heil mentioned the Sandoval County Fair July 30, 2018 through August 5, 2018. County Manager Dianne Maes mentioned on August 16, 2018 the County Commission will be hosting an Economic Development Course 101 and are inviting all entities including tribal, municipalities, mayors, C-Board members and staff at 8:30 in the morning.

Jamie Silva-Steele, President and CEO of UNM Sandoval Regional Medical Center presented and requested that language regarding the mill levy be placed on the November ballot for consideration. Former Commissioner Donnie Leonard and Former Commissioner Daymon Ely both spoke in favor of the mill levy.
