# SANDOVAL COUNTY BOARD OF COMMISSIONERS REGULAR MEETING AGENDA

#### 1. CALL TO ORDER

Chairman Heil called meeting to order at 6:03 p.m. Present were Chairman Heil, Vice Chairman Block, Commissioner Bruch and Commissioner Meek, Commissioner Eichwald was present via telephone.

### 2. PLEDGE OF ALLEGIANCE AND NEW MEXICO PLEDGE

Chairman Heil led Pledge of Allegiance and New Mexico Pledge

Chairman Heil announced "After the Agenda was posted on Monday, March 4, 2019, the name of Commissioner Jay Block as the sponsor of presentation by One Day at a Time Ministry. The Agenda was not substantially changed, but merely added additional information on March 6, 2019."

### 3. INTRODUCTIONS & ANNOUNCEMENTS

Chairman Heil advised that he and Commissioner Bruch attended the NACO meeting in Washington, and that a presentation to the Commission will be scheduled at a future date. Vice Chairman Block mentioned the Bureau of Labor Statistics on the top ten fastest growing states, which New Mexico was not one of them, also advised that the right to work is being debated in the senate judiciary committee on Friday, Vice Chairman Block advised that he "was there last night, but they were playing a basketball game and did not get in their committee, which I guess is more important." Vice Chairman Block spoke of the Veteran's Exception for tax purposes and purposed that a resolution that knocks the property tax down 25% or 50% to those veterans that are 50% to 90% disabled, and would like as a symbol that we are a veteran friendly state. Vice Chairman Block advised that he spoke to the County Assessor concerning her hire of a cousin as her Deputy Assessor, and does not think that this is a very smart move and it looks bad for the county and looks like nepotism. County Manager Dianne Maes introduced Dora Dominguez as the Economic Development Director and asked Ms. Dominguez to address the commission and tell the commission a little bit about herself. County Manager Dianne Maes further advised of a letter requesting participation by the elected officials for an upcoming working group county wide economic development strategy March 19, 2019.

Commissioner Bruch motioned to remove Agenda Item 9. Motion died due to lack of second. Vice Chairman Block motioned, seconded by Commissioner Meek. Clerk Eileen Garbagni called for vote. Commissioner Bruch voted no. Motion passed. Vote was 4-1

Elizabeth Dwyer expressed her concerns. County Assessor Linda Gallegos spoke of her decision to hire her Deputy Assessor and requested that she be trusted in her decision, as she is here to fulfill the duties that she was elected to do and requested that the Commission give her Deputy Assessor a chance. Madam Treasurer Laura M. Montoya advised that she will be sending a list of priority list updates and wanted to clear the record that the Senate Judiciary Committee were on the senate floor until almost mid-night due to a filibuster and that the game was cancelled, and that they were taking care of business the way our elected public servants should be.
