1. CALL TO ORDER

Chairman Heil called meeting to order at 6:00 p.m. Present were Chairman Heil, Vice Chairman Block, Commissioner Bruch, Commissioner Meek and Commissioner Eichwald.

2. PLEDGE OF ALLEGIANCE AND NEW MEXICO PLEDGE

Chairman Heil led the Pledge of Allegiance and the New Mexico Pledge.

3. CLOSED SESSION ANNOUCEMENT

(David J. Heil, Chairman)

Chairman Heil stated for the record "As previously noticed, immediately prior to today's meeting, on July 25, 2019 at 4:30 p.m., the Sandoval County Board of County Commissioners convened as a Committee of the Whole in a closed session in the 3rd Floor Conference Room, County Administration Building to discuss matters subject to the attorney-client privilege pertaining to potential litigation against the County Commission and discuss bargaining strategy preliminary to collective bargaining negotiations pursuant to the Open Meetings Act, NMSA 1978, §§ 10-15-1(H)(2) and (5). The matters discussed in the closed session were limited to those specified in the Notice of Closed Session and no action was taken.

4. INTRODUCTIONS & ANNOUNCEMENTS

County Clerk Eileen Garbagni informed the County Commission and the public about the changes to the Commission on the re-numbering of their districts changed by Bill 407 taking effect immediately, also letting the Commission know that 80,000 registered voters would be getting notified of this change. County Manager Dianne Maes read into the record a letter sent to the Board of County Commissioners about the critical capital improvements and upgrades at the Detention Center in Sandoval County (See Attached). Vice Chairman Block stated Commissioner Meek's mother in law passed giving him his condolences, also introduced Col. Chris King, also advised people to visit the Program called Squeaky Shoes Project on facebook. Commissioner Eichwald invited everyone to the Cuba Fair.

5. APPROVAL OF AGENDA

Vice Chairman Block motioned to approve, second by Commissioner Eichwald. County Clerk Garbagni called roll. All in favor.

6. OFFICE OF THE COUNTY MANAGER

Request a motion to adopt Ordinance No. 7-25-19.6 authorizing a loan in the amount of \$3,600,000 to finance the acquisition of solid waste vehicles, IT equipment and fleet vehicles.

(Rob Burpo, Financial Analyst and Daniel Alsup, Bond Attorney)

Rob Burpo and Daniel Alsup, Bond Attorney presented.

Vice Chairman Block thanked Mr. Burpo and Mr. Allsup for providing the information also asked Mark Hatzenbuhler, Public Works Director for the number of vehicles throughout the County, Mr. Hatzenbuhler stated there are 699 in the whole fleet, but of those, that includes the heavy equipment vehicles, used by the Sheriff's Office, vehicles used by Fire Department and the Assessor's Office, along with Mr. Hatzenbuhler was Martin Aguilar the mechanic shop manager and he also stated they were in dire need of getting rid of some vehicles that are no longer able to be repaired. With only 6 mechanics and in a hot shop it is very hard to keep up with all that is needed in the vehicles the County has. County Manager Maes met with Mr. Hatzenbuhler to discuss the issue on vehicles. Vice Chairman Block wants County Manager to meet with Mr. Hatzenbuhler to get a cost savings committee together to see how they can save money.

Vice Chairman Block motioned to approve, second by Commissioner Eichwald. County Clerk Garbagni called roll. All in favor.

Madam Treasurer introduced her mother, Mrs. Montoya and her goddaughter. Madam Treasurer presented the NACO conference she attended now in July in Las Vegas Nevada.

Madam Treasurer wanted to inform the elected officials about the supreme courts September 13, 2019, also stated that Assessors and Treasurer's met to discuss the mill levy, and has now the delinquent list that has around 600 accounts that are under \$125.00, auction will be soon. Other constituents spoke about the raise for the Sheriff's Deputies. Vice Chairman Block read a statement from Ana Kause that resigned for the position she had with the county.
