## SANDOVAL COUNTY BOARD OF COMMISSIONERS REGULAR MEETING MINUTES ADMINISTRATIVE BUILDING COMMISSION CHAMBERS October 3, 2019

# 1. CALL TO ORDER

Vice Chairman Jay Block called the meeting to order at 6:02
