



## **SANDOVAL COUNTY PLANNING & ZONING**

### **CHECKLIST FOR COUNTY REVIEW PRIOR TO BUILDING PERMIT**

#### **New Construction – Site Built**

- Copy of Deed or Survey of Property
- CID or Town of Bernalillo building permit application (County must sign for Zoning, Floodplain and Addressing)
- Building Plans – 2 Complete Sets (one set is kept at Sandoval County)
- Copy of the stamped (approved) New Mexico Environment Dept (NMED) Liquid Waster Permit and Floor Plan
- Site Plan & Vicinity Map
- \$75.00 Review Fee & \$5.00 Address Fee / Non Residential \$0.25 per square foot & \$5.00 Address Fee

*\* NOTE: Approved Drainage Plans are required for specific subdivisions.*

#### **Additions**

- CID or Town of Bernalillo building permit application (County must sign for Zoning, Floodplain and Addressing)
- Building Plans – 2 Complete Sets (one set is kept at Sandoval County)
- Site Plan & Vicinity Map
- \$75.00 Review Fee
- Bedroom Addition(s) – The NM Environment Department must approve updated plans.

#### **New Construction – Modular Construction**

- Copy of Deed or Survey of Property
- Copy of Building Permit Issued by CID
- CID Application for Foundation Only
- Copy of Foundation Plans
- Copy of the stamped (approved) New Mexico Environment Dept (NMED) Liquid Waster Permit and Floor Plan
- Site Plan & Vicinity Map
- \$75.00 Review Fee & \$5.00 Address Fee

*\*After zoning review and issuance of an address by Planning & Zoning, application and plans must be taken to CID at 5500 San Antonio Dr NE for review and issuance of building permit. CID inspectors perform inspections within Sandoval County's jurisdiction. Properties located within a 3 mile perimeter of the Town of Bernalillo will permit through the Town of Bernalillo address rather than CID.*

#### **Manufactured Home/Mobile Home Placement:**

- Copy of Deed or executed purchase agreement with copy of Deed from property owner and Survey of Property
- Copy of the (approved) NM Environment Department (NMED) Liquid Waste Permit and Floor Plan
- Site Plan & Vicinity Map
- Foundation Plans with engineering stamp
- Copy of the Installation Permit issued by the NM Manufactured Housing Division (NMMHD) OR Installation and Foundation Permit issued by NMMHD permit (required for Rio Rancho Estates)
- Title with Serial Number or purchase agreement with copy of the title from the owner, Proof of Age and Manufacturer/ Document with age and Manufacturer
- \$75.00 Review Fee and \$5.00 Address Fee



**Foundation Only – For Manufactured Home**

- Copy of Deed or Survey of Property
- CID Application (County must sign for Zoning, Floodplain and Addressing)
- Foundation Plan
- \$75.00 Review Fee

*\*No utilities or address will be issued on foundation only permits for manufactured homes.*

**Retaining Walls:**

- Copy of Deed or Survey of Property
- CID or TOB building permit Application
- Site plan
- Wall/Foundation Plan stamped by a NM registered Engineer or Architect
- \$75.00 Review Fee

**Fence (over 6 feet in height):**

- Copy of Deed of Property
- CID or TOB building permit Application
- Site plan
- Wall/Foundation Plan
- \$75.00 Review Fee

**Swimming Pools:**

- Copy of Deed of Property
- CID or TOB building permit Application
- Pool Plan – (must include all required fencing/walls as well as gates)
- \$75.00 Review Fee
