1. CALL TO ORDER

Chairman Heil called meeting to order at 6:15 p.m. Present were Chairman Heil, Vice Chairman Block, Commissioner Bruch, Commissioner Meek and Commissioner Eichwald.

2. PLEDGE OF ALLEGIANCE AND NEW MEXICO PLEDGE

Chairman Heil led the Pledge of Allegiance and New Mexico Pledge earlier during the Board of Finance Meeting.

3. CLOSED SESSION ANNOUNCEMENT

(David J. Heil, Chairman)

Chairman Heil stated for the record "It was previously noticed that the Sandoval County Board of County Commissioners would convene as a Committee of the Whole in a closed session immediately prior to today's meeting. For administrative reasons, the Commission did not hold a closed session today. Commissioners did meet individually with County Manager and Human Resources to discuss Salary Survey and adjustments to market salary increases and we expect to have an action on the January Agenda".

4. INTRODUCTIONS & ANNOUNCEMENTS

Commissioner Bruch was pleased to announce the great turnout at the Town of Bernalillo Annual Christmas Parade and mentioned that the Sheriff's Office placed 3rd in the government agency competition. Further, Commissioner Bruch announced that she attended the Southern Pueblo's Council Meeting this week and wanted to make everyone aware that there are issues, some of our pueblo's do not have their own police department and of course the BIA is their law enforcement on the ground, there are few of the officers, there is about 6, so they are policing a large area and significant population. Please keep all law enforcement in your thoughts and prayers during the holiday season because we have an increase in incidents during the holiday season. Lastly, the senate presented a bill that was unanimously passed of the Energy and Natural Resources Committee today which removed mining from the BLM Tracts that affects the Placitas Community, Chairman Heil introduced Fred Shepard as the CEO for Sandoval Economic Alliance and asked him to say a few words. Mr. Shepard stated that he had the pleasure of meeting a few of you over the last several years and looks forward to working with and for you. Chairman Heil announced a couple of amendments to the agenda and stated that he would entertain a motion to move Agenda Item 12B to be heard after Agenda Item 6 and Agenda Item 10A to be heard after 12B.
