County Administration Building will be open to the public beginning June 8th

Sandoval County, NM — Sandoval County's Administration Building will be open to the public beginning June 8th, 2020 during regular business hours from 8 a.m. to 5 p.m. Monday through Friday. This reopening only affects Building D located at 1500 Idalia. Citizens are advised to continue to limit their visits as much as possible but may receive services at the windows of the Probate Judge, Assessor, Clerk, Treasurer and Planning and Zoning Offices. County Commission meetings are still closed to the public until further notice.

All county departments will still follow all health precautions and facilitate social distancing practices with employees and visitors to the building. All county employees and visitors entering the administration building are required to wear face coverings in common areas.

The public will enter and leave through the front entrance only. The other doors will not be unlocked for entry. Rules for entering the building will be posted at the front entrance.

The county has also set up a Seek-Scan Thermal Imaging system at the front entrance, which will be used to scan and automate the body temperature of each visitor to the administration building.

The county will continue to follow the Governor's and Health Department's orders. A new Sandoval County Emergency Management Policy "Pandemic Procedure and Protocols during a Health Emergency" has been taken to the Board of County Commissioners and passed.

Community Services

- Community Health Program eligibility screenings and enrollments will continue to be conducted remotely with select curbside or in-house exceptions administered at the Health Commons building beginning June 15th and under strict COVID safe practices. For questions please phone: 221-4427.
- Prevention and Intervention Programs will continue to be conducted remotely with select curbside or in-house exceptions occurring at the Old County Courthouse building beginning June 15th and under strict COVID safe practices. For questions please phone: 362-6010.

All Center activities remain suspended until further notice and as authorized by the State.

- **Beginning July 6th**, our drive-through and home-delivered meal services for Seniors will return to five days per week (M F). Please rest assured that our strict and stringent adherence to COVID Safe Practices (CSPs) will continue, and please additionally rest assured that continued and consistent check-in calls remain unobstructed.
- County-sponsored Food Pantries continue under our ongoing strict mitigation
 modifications and in full compliance with CSPs, inclusive of outdoor
 distribution of pre-packaged "to go" boxes with proper social distancing at all
 times by staff and patrons alike.
- Transportation services for Senior residents continue for necessary
 appointments but with not more than two patrons at time in County vehicles per
 current State guidance. Vehicles are disinfected before and after each service
 and drivers remain in strict compliance with CSPs and are properly outfitted
 with recommended PPE.
- All Senior Volunteer Programs remain cancelled less those that occur remotely and safely (such as mask-making from home with County-provided supplies, check-in calls from Senior Companions, and related examples).
- In Home services continue to be modified based upon a Center for Disease Control (CDC) screening tool with remote-based case management services

while homemaker services remain suspended until further notice and as authorized by the State.

Fire/ Rescue

• Sandoval County Fire Rescue Administrative Staff will continue to operate with limited staff during normally scheduled hours.
