MEDICAID REQUIRED DOCUMENTS

- Applicants Picture ID
- Medicaid for a child, if child is 16 years or older; the child's ID (school ID or driver's license)
- Adult Expansion (If applying for Family; spouses ID is required)
- Utility bill (<u>NO CELL PHONE</u> bill), lease agreement or letter of residency is acceptable for address verification.
- Original Birth Certificate for everyone that is applying for Medicaid (proof of birth or notification of birth may be used if child is under the age of one).
- Social Security Card (if not available, a letter from Social Security Administration to prove that you have applied for Social Security (required for everyone that is applying for verification purposes).
- Proof of Income (check stubs etc.) or letter of support for the past 30 days.
- If applicant is pregnant, (estimated due date).
- If applicant has private insurance, you must provide health insurance card.
- Retroactive coverage maybe available for 90 day prior to date of application.
- Disability Medicaid (proof of disability may be required).

QMB/SLIMB/WDI REQUIRED DOCUMENTS

If you received a letter from Social Security stating that you may be eligible for QMB, please bring the following documents.

- Applicants Picture ID
- Utility bill (<u>NO CELL PHONE</u> bill), lease agreement or letter of residency is acceptable for address verification.
- **ORIGINAL** Birth Certificate for everyone that is applying.
- Social Security Card (if not available, a letter from Social Security Administration to prove that you have applied for Social Security (required for everyone that is applying for verification purposes).
- Proof of Income (check stubs etc.) or letter of support for the past 30 days.
- Proof of income (check stubs etc.) or letter of support for the last 30 days.
- Medicare Card: Must provide Medicare Card and have Part A and B.
- If applicant has private insurance, they must provide their health insurance card.
- Resources: Vehicles (make, model and year).
- Bank Accounts: Name of Owner, Account Number, Amount in Account.
- Other Assets: Cash on Hand, real property (other than home), life insurance(s), royalties, burial funds, stocks, bonds, certificate(s) of deposit, IRA's trusts, livestock and any other assets you and your spouse own.
- Applicant for WDI proof of disability may be required.
