Statement on behalf of KATHLEEN GROODY Case No. M-49-CV-2016-00004 Non Jury Trial before the Honorable Donna Bevacqua-Young

Kathleen Groody has been a close personal friend for more than thirty years. During that time I have seen her succeed, first as an entry-level member of a Laboratory of Anthropology field crew, digging at various cultural sites. Then as a self-supported student, a fine single mother and finally, as a respected scientist, beginning a well-earned retirement in her beloved northern New Mexico. Based on my knowledge of her character, I can state with confidence that she would never fail to pay for goods or services properly delivered. It is simply not in her makeup.

Between December 5th and 8th, I visited Kathleen in the community of Sile, New Mexico, at the small farm she recently purchased with savings from her career as a soils scientist with the State of California. I found her in the midst of building an attachment to the one-bedroom adobe house that came with her acreage. The construction appeared to be progressing normally except for some notable conflict with the work of a designer Kathleen had retained to produce drawings for the project. I'm certain The Court will be provided the adequate details of this conflict, however, I will take this opportunity to relate two events I personally witnessed and consider relevant:

On Dec. 6, 2015, I was with Kathleen when she received a phone call from Mike Coca. I heard her say that his work on the project was a mess and full of problems that he'd deflected and was never available when needed. Obviously, I was not privy to the whole conversation but I distinctly heard her tell the designer that their relationship had been terminated and that he was to do nothing more for her or in her name. After she hung up, Kathleen was visibly very upset, stating that the designer's response had been personally derogatory and insulting. She told me that he'd said she was "too cheap" to pay him to come out, didn't want to pay ... and that *she* was the problem because she was involved too much.

On the next day, December 7th, about 8:00 A.M., Kathleen called Inspector Mr, Julian Gonzales for permission to pour her footings. He requested photos, which she took as I watched and emailed to him at 8:52. He told her to go ahead and pour, but to install a grounding rod, so I went with her to Santa Fe to buy blocks and the rod. the Builder installed, and the Concrete Pour she'd ordered proceeded on schedule around 1:30, with me taking further photos of the Pour. That evening, at the home of Elaine Gilmartin where I was staying, she found messages from Mr. Coca on her cellphone, to the effect that he'd called for an inspection of her old footing - she was quite upset and determined to contact the Inspector in the morning to make sure he knew Mr. Coca had no authority on her job. Ms. Gilmartin and I agreed that was the best thing to do.
