# 1. CALL TO ORDER

Vice Chairman Block stated that the Corrales Police and Sandoval County Sheriff stated that a pony was mutilated in Corrales. Vice Chairman Block asked the new County Manager to sit for him to listen to this, in 2016 when Commission Heil, Eichwald and himself came into office they were confronted with problems that were ignored or given priority. I have to agree that we have solved more issues and problems in the three years than any time in recent history in the County. I want to thank the incredible staff and contractor personnel dedicated to serve the public. The Sheriff's office is the animal control authority for Sandoval County. Chairman Heil purchases this shelter to ICIP last year with the intent to prioritize it. This is why we've considered going to bond, but such considerations were abated due to the current economic crises. Reason for budget and approve funds to purchase a climate controlled high quality tiny shelter intended to house impound animals before being transferred to adopt. I propose we task the new County Manager to begin and develop a plan for the permanent location, and funding. Commissioner all made several comments. Motion made by Vice Chairman Block, second by Commissioner Bruch. Vote was unanimous.
