



SANDOVAL COUNTY BOARD OF COMMISSIONERS


1. CALL TO ORDER
Chair Heil called the meeting to order at 10:00a.m. Present were Chair Heil, Commissioner Bruch and Commissioner Block via telecommunication.
2. APPROVAL OF AGENDA
Commissioner Bruch made a motion to approve. Second by Commissioner Block. Commissioner Bruch, Commissioner Block and Chair Heil voted yes. Motion passed unanimously.
3. OFFICE OF THE COUNTY ASSESSOR
(Linda Gallegos, County Assessor)
Request for a Motion to Adopt Resolution No. 9-9-21.3 Approving the Sandoval County Order Setting Property Tax Rates for 2021 Property Tax Year.
County Assessor, Linda Gallegos presented. County Manager Johnson clarified the motion is to impose the tax rates as defined by DFA since approving or disapproving is not an option.
Commissioner Block made a motion to approve. Second by Commissioner Bruch. Commissioner Bruch, Commissioner Block and Chair Heil voted yes. Motion passed unanimously.
County Manager Johnson stated for the record that the tax rates were sent out to all taxing entities within the County and have not received any changes nor have they identified any inaccuracies in the rates being set.


