Chief Deputy Clerk Joey Dominguez presented the Command Center reports and mentioned that Sandoval County was the only county to utilize remote surveillance monitoring and answered questions from the Commissioners accordingly.

Commissioner Bruch made a motion to approve the canvass, seconded by Vice Chair Meek. Commissioner Bruch, Vice Chair Meek, and Chair Heil voted yes. Motion passed unanimously.

Bureau of Elections Manager Tina Dominguez thanked the BOE staff and the other County Departments.

Chief Deputy Clerk Joey Dominguez thanked legal department and the County Manager for delegating his team to assist with the election.


4. ADJOURN
