2. As well as beginning at the point of intersection of the Los Alamos/Sandoval county line and the Santa Fe/Sandoval county line,
and proceeding easterly along the Los Alamos/Sandoval county line to the Santa Fe/Sandoval county line,
and proceeding southerly along the Santa Fe/Sandoval county line to the point of beginning.
