1. CALL TO ORDER: Chair Meek called meeting to order at 5:04 p.m.
Present were Chair Meek, Commissioner Bruch, Commissioner Block, Commissioner Eichwald and Vice Chair Heil via telecommunication.
2. APPROVAL OF AGENDA

3. OFFICE OF THE COUNTY MANAGER
(Wayne Johnson, County Manager)
Request for a Motion to Adopt Resolution No. 8-16-22.3 Sandoval County Emergency/Disaster Declaration Regarding the water supply of the Village of Cuba.

Theresa Greeno presented, the declaration gives Cuba access to emergency funds and resources through the Department of Homeland Security and Emergency management. The Village of Cuba did declare a local emergency that passed in a meeting yesterday within the village, this would be the next step for them to accomplish to request that additional assistance.

Vice Chair made a motion to approve, seconded by Commissioner Block. Commissioner Bruch, Commissioner Block, Commissioner Eichwald, Vice Chair Heil and Chair Meek, Vice Chair Heil, voted yes. Motion passed unanimously
4. COMMENTS FROM THE COMMISSIONERS

Vice Chair Heil inquired as to what happened, as Theresa Greeno deferred that question to Mayor Herrera. Mayor Herrera stated they were attempting to work on the transmission lines from the well to their storage tank. When the pressure ran through to unclog the blockage, the fire department was called and had to use 7-9 trucks loads of water which depleted the water.


Commissioner Block offered his apologies to the city of Cuba and inquired as to what the cost was to replace the infrastructure. Mayor Herrera advised that they had received an estimate to replace which was 2,000,000.00.

Commissioner Eichwald advised there has been quite a few issues in Cuba over the past few years. Other water sources and infrastructures have been discussed.

Chair Meek assumes that they will be looking at alternate sources of water as they trying to repair it and look at the best option, as it may escalate beyond that.
