- 1. Introductions Natashia Remchuk Tourism & Event Coordinator provided welcome as new County Tourism Coordinator. She started with Sandoval County Tourism, October 2022 and busy since. New attendee included Zachary Herrera, Cuba Town Councilor.
- 2. Lodgers' Tax Financial Report
  - a. FY23 Budget w/prior year carryover D. Dominguez provided an year-to-date update for lodgers' tax. Current revenue (including FY22 carryover is \$30,548.78. Total Expenditures, part-time seasonal employee is \$5,308.96. Other expense was lodgers' tax match to outdoor recreation technical assistance grant of \$4,000. - 4. TRENDS Conference/ NM Hospitality Updates D. Dominguez attended and provided a summary of TRENDS Conference, which took place in Santa Fe on January 23-24.

Trends Conference is a marketing, research, and advocacy conference held annually in Santa Fe. During the TRENDS Conference an NM True initiative was showcased. The video created called, The Face of Hospitality in New Mexico," was presented.

## LEGISLATIVE PRIORITIES

New Mexico Hospitality Association (NMHA) legislative priorities during the 2023 Legislative Session that started on January 17. Here are the current policy priorities are:

- Support a robust, comprehensive Tourism Department marketing budget to share New Mexico's story and continue to bring travelers and events back to New Mexico
- Continue to develop and fund programs that assist local communities with marketing and event development (event support, co-op marketing, etc.)
- Develop and support existing workforce programs that address both the short-term and the long-term needs of the industry to build back to pre-pandemic staffing levels
- Develop policies that ensure all lodging providers are on the same level playing field
- Ensure that the travel and tourism industry is included and prioritized as policy and funding programs continue to be developed (the industry needs more than loan programs to rebuild establish tax incentives/deferrals to help businesses address the looming debt crisis and to allow them to invest in workforce retention and development)
