Regarding the ordinance banning of feeding of wild horses :

In my opinion, this proposal is rushed and extreme and will not solve any problems. It punishes the legally wild horses for merely existing here and it punishes the people who actually care about the well being of the horses. This proposal also states that it is punishable to help a stray dog who comes onto the property. This is outrageous. This proposal lumps all sorts of animals together; predators, non-predators and docile wildlife. It was obviously written by someone who doesn't like or understand animals and has no idea what kind of negative impact this proposal would create. The legally wild horses need to be protected, not punished. A stray dog needs help in finding it's owner and needs protection until the owner is found.
