Come next budget year Ma'dam clerk will be requesting more technicians, Bureau of Election Coordinator, Administrative Assistant and an increase of wages for my current employees, more money for training the poll worker's and a warehouse bigger than 9800sq. of space that we now have. We must move forward and act as the class act county we are.

MA' dam Clerk directed the rest of the presentation to Chief Deputy Clerk, Joey Dominguez. Chief Deputy Clerk, Joey Dominguez wanted to thank everyone for their hard work. Through transparency he wanted to identify the errors that arose during this election.

Chair Meek made a motion to approve the canvass, seconded by Commissioner Eichwald. Commissioner Bruch, Commissioner Eichwald, Vice Chair Heil and Chair Meek, Commissioner Block, voted no. Vote was 4-1.
