15. COMMISSIONERS DISCUSSION

Commissioner Block discussed one of the things going on in the roundhouse is a big thing that gets shot down every year is school vouchers and school choice. Another thing the state of New Mexico doesn't allow parents to do to pick your own schools because you're forced into a school in your zip code. When you look at the public-school systems in the United States, take Baltimore, for example. After the pandemic only 7% of third through eighth graders students in Baltimore were proficient in math. Since the pandemic, at least 23 Baltimore schools, zero students tested proficient in math and during the peak of the pandemic in 2021, Forbes magazine reported that one mother covered her high school student, senior, had a GPA, Mr. Chair, of 0.13, which is just a little bit higher than Chief Fenders in college. That means he failed all three classes in high school, yet he ranked sixty-second out of one hundred and twenty in his class. That's just unbelievable, it shows you a failure of schools and why we need more choice. Chair heil discussed how we let our children get manipulated and mutilated? This will be the question of future generations when I look back at the action of the New Mexico-legislation in 2023. When they passed legislation that encourage the doling out of puberty blockers hormones like they were candy, and in some cases removing functional body parts, and doing so the exclusion of parental guidance. How little young people were being misled by groomers, understanding the profound impacts that changing gender would have on their lives. bodies, and lives while the groomers downplay negative consequences and emphasize the need for gender transition when what they really may have needed was guidance to deal with personal confidence issues typical with many young people, and that guidance coming from parents. While other states are taking steps to prevent such defiling of children, New Mexico is running headlong into the abyss of children manipulation and mutilation. Vice Chair Meek discussed, the importance of the county's involvement with all the economic development partners we have. He stated we are lucky we have Director Dominguez in-house, but as you heard Fred Sheperd from Sandoval County Economic Alliance say, we have to keep filling with prospects. That's the reason we are involved with SEA and the reason we're involved with the Rio Rancho Chamber of Commerce. Commissioner Bruch wanted to thank everyone who came this evening, she also wanted to thank the chamber for the coordination of the 120th anniversary at the legislator. I appreciate our new Deputy County Manager, Mr. Garcia, being there with us, it was wonderful to be on the floor of the house. I'm sorry I missed the senate side, but we received a very warm bipartisan welcome.
