1. CALL TO ORDER

Chair Heil called meeting to order at 6:00p.m. Present were Chair Heil, Commissioner Block, Commissioner Jones, Commissioner Bruch and Vice Chair Meek via telecommunications.

Commissioner Jones wanted to take a quick moment to thank John for being here.
