Request for a Motion to Adopt Ordinance No. 11-8-23.10B authorizing the issuance and sale of a Gross Receipts Tax revenue note or other obligation in an aggregate principal amount not to exceed \$18,000,000 and the execution of a related loan agreement to finance the cost of designing, constructing and equipping a new district court facility for Sandoval County.

C. Request for a Motion to Adopt Ordinance No. 11-8-23.10C authorizing the issuance and sale of a lease revenue note or other obligation in an aggregate principal amount not to exceed \$19,000,000 and the execution of a related loan agreement to finance the cost of designing, constructing and equipping a new magistrate court facility for Sandoval County.

Commissioner Block made a motion to approve, seconded by Commissioner Bruch. Chair Heil, Vice Chair Meek, Commissioner Bruch, and Commissioner Block, voted yes. Motion passed unanimously.

D. Request for a motion to Adopt Ordinance No. 11-8-23.10D authorizing the issuance of a revenue bond and a loan from the New Mexico Finance Authority payable from net system revenues from the county's landfill and revenues attributable to the existing County Environmental Services Gross Receipts Tax for the financing of equipment for the County's landfill in an aggregate principal amount not to exceed \$3,200,000 and the execution of a loan agreement, an intercept agreement, and other related documents to be approved at a later date by the Board via a supplemental resolution.

Commissioner Block made a motion to approve, seconded by Commissioner Bruch. Chair Heil, Vice Chair Meek, Commissioner Bruch, and Commissioner Block, voted yes. Motion passed unanimously.

E. Request for a Motion to Adopt Ordinance No. 11-8-23.10E authorizing the issuance of a revenue bond and a loan from the New Mexico Finance Authority payable from revenues attributable to an existing County Gross Receipts Tax for various County Projects in an aggregate principal amount not to exceed \$5,600,000 and the execution of a loan agreement, an intercept agreement, and other related documents to be approved at a later date by the Board via a supplemental resolution.

Commissioner Block made a motion to approve, seconded by Commissioner Bruch. Chair Heil, Vice Chair Meek, Commissioner Bruch, and Commissioner Block, voted yes. Motion passed unanimously.
