1. CALL TO ORDER

Chair Heil called the meeting to order at 1:00pm. Present were Chair Heil, Vice Chair Meek, Commissioner Bruch, Commissioner Block and Commissioner Jones.

2. Request for a Motion to Approve the Canvass for the 2024 Municipal Office Elections (MOE).
 (Anne Brady-Romero, County Clerk)

Chair Heil discussed the canvassing of Municipal Officer Elections and wanted to make a couple of points. The commissioner's authority to certify the elections is basically the authority to verify the Clerk's have turned in their homework. We have no authority to review machines, we have no authority to certify machines have been certified, we have no authority to touch ballots etc. Chair Heil turned the floor over to Rebecca Martinez, City Clerk, from the City of Rio Rancho.

Rebecca Martinez provided the report for Canvass. Rebecca Martinez, City Clerk discussed that out of the registered voters 7% chose to cast a ballot in the election. Of those 2,864 turned out on election day, 2086 on early voting day and 185 during absentee. There were 6 provisional ballots on election day. Provisional ballots issued to individuals not found administration system, they issued a ballot. Of those 6 provisional ballots, four of them qualified and two disqualified. One was due to not living in the City of Rio Rancho and the other due to not presenting an ID on election day. As you know every voter who is issued a ballot must present an ID.

Commissioner Block made a motion to approve, seconded by Commissioner Jones. Chair Heil, Vice Chair Meek, Commissioner Bruch, Commissioner Block, and Commissioner Jones, voted yes. Motion passed unanimously.

3. ADJOURN

Commissioner Block made a motion to adjourn, seconded by Commissioner Bruch, meeting adjourned at 1:56P.M.


