

## **BUSINESS REGISTRATION REQUIREMENTS**

## **Business License Requirements:**

- Applicant must provide a clearance letter from Sandoval County Planning and Zoning.
- Applicant must provide the NM Taxation and Revenue Department Tax ID Number.
- Applicant must complete the Business Registration form.
- Temporary Business License is issued until Planning & Zoning completes a physical inspection.

## <u>PLEASE NOTE:</u> ALL BUSINESS WILL BE GIVEN A TEMPORARY BUSINESS LICENSE UNTIL PLANNING AND ZONING HAS COMPLETED AN INSPECTION FOR ALL HOME-BASED BUSINESSES WITHIN 30 DAYS. AFTER APPROVAL THE BUSINESS LICENSE WILL BE MAILED.

Enclosed is the business license registration to operate your business in Sandoval County as per business license ordinance 01-12-6.9A, passed at a Regular Commission Meeting December 6, 2001. The Annual registration fee is \$35.00 per year. A later fee of \$10.00 will be assessed if the business license renewal application is received late.

Please note a Clearance Letter from Sandoval County Planning and Zoning must be included with your business registration.
