#### 15. COMMISSIONERS DISCUSSION

Commissioner Bruch emphasized the importance of recognition in County resolutions, noting that the Public Information Officer strives to acknowledge community issues regularly. She highlighted suicide prevention as a top priority and commended the work done with the Emergency Manager to improve preparedness. Chair Meek shared that he participated in the "United Against Fentanyl" walk, organized by families who have lost loved ones to the drug. He reflected on the powerful and heartbreaking stories shared at the event and described the walk from Main Street to one of the parks. He thanked Kelly for the invitation and noted that increased fentanyl awareness activities are taking place in the community. Commissioner Herr discussed the dangers of fentanyl, sharing that friends of his have lost children to the drug. He also addressed the proclamation on prostate cancer awareness, explaining that while the disease often affects older adults, a growing number of individuals under 50 are being impacted, many of whom go undiagnosed.
