



**COUNTY OF SANDOVAL RESOLUTION
AMENDING RESOLUTION NUMBER 7-23-25.11F
DESIGNATING THE POLLING PLACES
FOR ALL STATEWIDE ELECTIONS
CONDUCTING IN 2026 AND 2027**

RESOLUTION NO. 3-11-26.11A

WHEREAS, pursuant to the New Mexico Statutes Annotated 1978, Section 1-3-2 in June or July the Board of County Commissioners by resolution shall designate the location of election day polling places in the county for the conduct of any statewide election conducted in calendar years 2026 and 2027; and,

WHEREAS, the Board of County Commissioners finds that each polling place designated in this resolution complies with the provisions of NMSA 1978, Section 1-3-7, titled Polling Places; and,

WHEREAS, the Board of County Commissioners finds that the Voting Convenience Centers created by this resolution will make voting more convenient and accessible to voters of the consolidated precincts, and will not result in delays in the voting process, and are centrally located within each consolidated precinct; and further that the Voter Convenience Centers created by this Resolution along with any Early Voting locations which the County Clerk determines to maintain open on Election Day as additional Voter Convenience Centers all meet the requirements of Subsections B and C of NMSA 1978, Section 1-3-4 and will be available to voters of any precinct in the county to cast a vote at any Election Day Voting Convenience Center; and,

WHEREAS, the Board of County Commissioners has signed a consent decree with the United States to provide access to polling places for individuals with physical mobility limitations; and,

WHEREAS, the Board of County Commissioners finds that each polling place provides individuals with physical mobility limitations unobstructed access to at least one voting machine; and,

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners designates the election day polling locations for any Statewide and Regular Local Election to be conducted in 2026 and 2027 identified in "Exhibit – A SC VOTING LOCATIONS RESOLUTION 2026-2027" 3.11.26-1stAmendment.
