1. CALL TO ORDER

Chair Juarez called meeting to order at 5:00p.m. Present were Chair Juarez, Vice Chair Herr, Commissioner Meek, Commissioner Jones and Commissioner Bruch via telecommunications.

2. STATUS OF THE TREASURER'S OFFICE

Treasurer Taylor discussed the status of the Treasurer's Office, including the departure of Rosemary Mora, the office's Vault Supervisor. In preparation for her departure, the office worked to ensure continuity by selecting an internal candidate, Consuelo Lucero, to fill the position.

Treasurer Taylor also discussed the upcoming Manufactured Home Auction scheduled for May 22. The auction has been placed on the County calendar, published in the newspaper as required by law, and posted on the County website. Treasurer Taylor noted that these auctions have been extremely successful. For 2025 and 2026, the County has collected \$132,189 on manufactured home accounts through these efforts.

Additionally, Treasurer Taylor reported that the office has been researching the implementation of online auctions. Approval has been received to move forward; however, online and in-person auctions cannot be conducted simultaneously. The office will proceed with transitioning to online auctions.

Treasurer Taylor also discussed the Junior County Treasurer Program.


